The American Association of Acupuncture and Oriental Medicine (AAAOM) strongly supports the [Coalition for Patient's Rights™](#) (CPR) efforts to defend a patient's access to all licensed health care providers. The AAAOM is expressly concerned about initiatives which limit patients' access to the services of licensed acupuncturists.

The AAAOM's mission is to promote excellence and integrity in the professional practice of acupuncture and Oriental medicine (AOM) to enhance public health and well-being. AOM is an original form of holistic medicine, which includes acupuncture, Asian herbal medicine, medical massage, diet modifications, and breathing and movement therapies. Acupuncture is one of the oldest, most commonly used medical procedures in the world. Originating in China more than 2,500 years ago, acupuncture gained the attention of the American public in [1971](#), during the Nixon Administration, when James Reston visited China and received post-operative treatment through acupuncture. The great degree of patient and physician acceptance of acupuncture in the United States is due in part to the rigorous credentialing and examination processes that practitioners are required to complete for licensure.
